Puppy Contract

Whereas, Ina and Claude McDonald of Takoda Shilohs, herein after called "seller" is the owner of a Shiloh Shepherd.....and further described as follows:

Whereas.....here and after called "Buyer" as person of purchasing the Shiloh Shepherd above.

In the sum of \$.....dollars, the seller conveys the above described Shiloh Shepherd to the buyer under the following warranties and conditions and no other warranties or conditions are either expressed or implied.

- 1. The prefix or suffix "Takoda" is required in permanently registering this dog/bitch and if not, this guarantee is null and void.**
- 2. The above described puppy is guaranteed for 72 hours to be in good health and free of communicable diseases at time of sale. Buyer is to have puppy examined by their veterinarian within this time period and to notify seller immediately of any concerns. If said dog/bitch is not examined within 72 hours the seller cannot be responsible for any subsequent health issues.....**
- 3. The above described puppy will be delivered to the buyer with all required immunizations as deemed necessary by sellers veterinarian. Puppy should be micro-chipped by buyer at their veterinarian in both buyer and seller's names.**
- 4. Buyer is responsible for picking up pup at seller's home or pre-arranged meeting place and will pay all costs.**

The seller has gone to great lengths to provide to you a healthy puppy. As of this date.....it is your responsibility to care for said puppy in every way possible. If buyer is not able to do so the seller is to be contacted immediately and at that time it will be the sellers option to reclaim the above mentioned dog/bitch at no charge. This dog/bitch may not be placed in another home

without the written consent of the breeder/seller. The seller also reserves the right to remove said dog/bitch at any time she /he feels that the health or well being of said dog/bitch is being compromised, or if terms of this contract are not honored. No refund will be due to the buyer for removal or returned dog/bitch.

The Sire and Dam of this litter have met all health testing requirements and the seller has made every effort to prevent future health issues. It is impossible to guarantee against genetic illnesses of nature, but the seller has made every effort to provide buyer with a healthy puppy.

1. The above described dog/bitch is guaranteed against crippling hip dysplasia as certified by Penn Hip or OFA under the following provisions

A) Breeding or Show Quality:

For up to 26 months after review by veterinarian of seller's choice said dog/bitch must be returned to the seller at buyer's expense along with registration paperwork. Replacement will be in the form of a puppy from an upcoming litter for the duration of the seller's breeding program. There will be no cash refunds to said buyer.....

B.) Pet Quality

For up to 8 months after review by veterinarian of seller's choice said dog/bitch must be returned to seller at buyer's expense along with registration paperwork. Replacement will be in the form of a puppy from an upcoming litter for the duration of the seller's breeding program. There will be no cash refunds to said buyer....

2. All puppies sold as breeding or show quality must have hips, elbows, heart and thyroid testing completed by the age of 26 months. If testing is not completed at that time all guarantees either expressed or implied are null and void. Copies of all testing results must be forwarded to the seller as documentation. This health testing will assist in our breeding program and in the planning of any future litters.....
3. All puppies sold as pet quality must be spayed or neutered no earlier than 4 months nor later than 6 months of age. The seller must receive written documentation from buyer's veterinarian that this procedure has been completed. At the time of this procedure, which said dog/bitch is under anesthesia a preliminary hip/elbow x-ray is required. If evaluation of hips/elbows is not completed at this time all guarantees either expressed or implied are null and void. Copies of all testing results must be forwarded to seller as documentation. This health testing data will assist in our breeding program and the planning of future litters....
4. Prior to breeding a Show or Breeding quality dog/bitch seller reserves the right to approve or reject any potential stud/bitch being considered. The

buyer must consult with the seller and all parties must be in agreement prior to any breeding taking place. Failure to comply with this provision will be viewed by the seller as a breach of contract which will result in the inability of the buyer to register any unapproved litters and my result in the removal of said dog/bitch from the buyer with no compensation. This provision is in place to protect our breeding goals for these lines and to ensure that all health and temperament testing has been completed prior to any breedings....

5. All puppies need to be socialized and seller recommends enrolling your puppy in a puppy class as soon as is possible . Seller also recommends use of a crate which will ensure the puppies safety when you are not home and will provide them with their own space. Said puppy is not to be tied to any type of chains, ropes. The buyer agrees to provide a fenced in secure area for said puppy.....
6. The buyer agrees to attend a minimum of 6 -8 weeks of obedience training with said puppy. A certificate of completion will be provided to seller as documentation. The seller will not be held responsible for any temperament or obedience issues, however, the seller will try to provide assistance in attempting to correct bad behaviors..

Please read this contract carefully, as it contains provisions regarding the health,safety and welfare of your future puppy. Please be advised that several of these provisions will incur additional expenses on your part. The execution of this contract binds you to your future puppy for the duration of his/her life, it is a MAJOR COMMITMENT. Our goal is to provide you with a healthy, loving member of your family. Your adherence to the provisions of this contract will benefit you, your puppy and the breeding program of Takoda Shiloh Shepherds.
